- e. Treasurer (Chuck):
 - Scholarship-Bursary Committee report Bursaries awarded to Peter Kaulfuss and Todd Fletcher (\$2000 each). Action: Scholarship committee will meet after scholarship application deadline on Feb.1, 2015.
 - ii. Motion by Ross to raise registration fees by 5% rounded to the nearest \$5 amount in H1 to Midget, and decrease Juvenile fees as per Chuck's proposal; Second: Bud. Carried. New fees: H1 \$315, H2 \$395, H3/4 \$425/Late \$475. Atom \$495/Late \$545, Peewee \$585/Late \$635, Bantam \$625/Late \$675, Midget \$630/Late \$680, Juvenile \$400/Late \$450.
 - iii. Proposed budget for 2015/2016 presented to executive. **Motion:** Chuck; Second: Ross. Carried.
 - iv. **Motion** by Chuck: To authorize destruction of accounting records older than 7 years. Second: Lynda. Carried.
- f. Registrar (Janet): All rosters for players are now frozen as of January 10th, 2015. Action: Janet will organize registration information on HCR, including the adapted fee structure, Code of Conduct statement and Media Release Form.
- g. Secretary (Vandy): arranged for a banner ad to run in the Spring Parks & Rec. Leisure guide.
- h. Coach Coordinator (Pete): absent. Report submitted.
 - i. Partial reviews on coaching done. Mostly really positive reviews, exception being a couple of coaches working on tactics versus team skills. **Action:** Once feedback is all in, Pete will send a report and follow up with issues.
 - ii. Coach evaluation form being reworked and would like to take away anonymity to provide accountability.
- i. Equipment Manager (Kevin): absent. No report.
- j. Ice Allocator (Lynda): last conflict game arranged for this set of schedules.
- k. Referee-in-Chief (Tristan): had some issues with a couple of refs that have now been dealt with.
- 1. Referee Allocator (Kelly): had an issue with a ref that has been dealt with.
- m. Division Managers: H1-2 (Desiree): H1 now at 21 players; H2 had their first league games this past weekend with both teams playing very well, H3-4 (Barb): H3 organizing the intermission games; H4 injury of a player has necessitated calling a number of H3 players up. Atom (Bud):

A1 holding own in flight 2; A2 is 2^{nd} in flight 4; Atom Cs are pretty even. Peewee (Greg): C teams are showing well in their flights; A team in a spring tournament in MR. Bantam (Tracy): teams doing fine. Midget (Jennifer): teams all participated in Herb House. A team won gold (first time in 6 years); C3 got silver and C1 got bronze. Juvenile (Christel) – nothing of note.

Tournaments Policy

- 1. All Atom C Teams are to participate in the *NWMHA Bobby Love "C" Tournament* scheduled in March for each hockey season.
- 2. All Peewee C Teams are to participate in the *NWMHA Al Hughes* "C" *Tournament* scheduled in March for each hockey season.
- 3. All Midget A and C Teams are to participate in the *NWMHA Herb House Midget International Tournament (A and C divisions)* scheduled in December for each season.
- 4. In order to apply and participate in any hockey tournament requiring overnight stays, a team must request a permission letter from the President of NWMHA. This request should be made in writing a minimum of 4 weeks prior to the tournament and must include the following information:

Team Name Head Coach Dates of Tournament City, Province/State Arena or Arena Name Name of Tournament Host Association Name

- 5. In order to keep team costs to an affordable amount for every player, the President of NWHA will approve one away tournament requiring overnight stays per A and C Teams in each division per hockey season. Any team wanting to enter a second tournament requiring overnight stays must submit a request to the President a minimum of six weeks in advance of the tournament outlining justification for the second tournament, evidence of parental support and detailing all associated costs. Note: Teams are expected to fundraise so the justification shows that there is unanimous parental support for this second 'away' tournament. We recognize that some players' families will simply 'cut a cheque'; however, some initiative needs to be demonstrated to the association thus ensuring that no single player's family is unduly penalized by a team decision.
- 6. NWMHA strives to provide each A Team and C Team a subsidy towards the cost of one hockey tournament (amount to be confirmed each September, dependent upon the association's budget for the upcoming hockey season).
